Please Keep a copy of these Regulations for your Records

- Having a stall at the Street Carnival is conditional upon compliance with all Market Regulations.
- Trading Hours are 8.00am to 1.00pm. Market Holders must trade during these hours.
- All cars must vacate the Town Centre by 7.30am. No cars will be allowed in the Town Centre after 8.30am. Cars will be allowed back in the Town Centre from 1.00pm.
- Market Holders will not insult or intimidate other Market Holders, Customers or Event Staff, such action will result in cancellation of Stall allocation.
- Customers shopping will be treated with courtesy and expert Fair Trading practice consistent with Consumer Law.
- Market Holders must comply with all instructions by Market and Event Staff.
- Stall allocation is at the discretion of the Market Co-ordinator.
- Boyup Brook Street Carnival is an open-air market that trades in all weather.
- A copy of your Certificate of Currency must be attached to your application.
- Payment is required to accompany the application form.
